- Have completed a Teacher Training qualification (PGCE, SCITT, TeachFirst or equivalent) and have QTS or equivalent.
- Be able to competently deliver teaching and tuition in your specialist area (subject and key stage).
- Have a dynamic, energetic, personable manner.
- Have excellent verbal and written communication skills.
- Have a good ability to plan and schedule.
- Have a solid knowledge base relating to the subject area being taught.
- Have the ability to motivate your students to study.
- Have patience and understanding.
- Have the ability to adapt to different learning styles.
- Have the ability to supervise your students and be a positive role model
- Seek to be positive and build up a good rapport with your student and their family
- Be courteous to colleagues and provide a welcoming environment to visitors and telephone callers.
- Have a great degree of resilience.
- Seek to help children and young people learn.
- Show self-awareness about how your behaviour can positively (or negatively) impact a student.
- Are open to sharing resources, information and ideas with other tutors in a collaborative way.

5. Registering as a Tutor - Successful candidates of the interview will, subject to clearing all checks, be invited to register as a tutor with CTG
